# Fees and commissions for individual customers

For operations in lei and foreign currencies

This edition came into effect starting with the 29th of July 2022 and  
replaces the previous edition of the 28th of July 2021

1. This brochure contains standard commissions charged by ALPHA BANK ROMANIA for the products and services offered to its customers. For those products and services not listed in this document, the commissions will be set and communicated by the Bank on a case by case basis, before the operation has been provided.
2. Commissions and fees are due and payable from the current account on the transaction date, irrespective if finalized at beneficiary or not (returning, non-acceptance, cancellation, expiry before utilization etc.). Exception: commissions and fees for operations that generate collection are calculated on the transaction date but will be charged at the first collection.
3. Commissions and fees are due and payable by the ordering party or the service applicant. In case the beneficiary pays the commissions their level is the same as herein mentioned.
4. When calculating the commissions listed "per quarter" timing must be understood as the entire period of 90/91/92 consecutive days and fractions thereof.
5. Mail or fast couriers charges, teletransmission fees as well as fees for special forms related to operations performed are added to the commissions listed herein and collected at the same time.
6. If VAT will be modified as a result of changes of legislation, the commissions that include VAT will be modified accordingly, without any other formality.
7. If the commissions/fees charged by settlement systems SENT( up to 50,000 lei), ReGIS ( $\geq 50,000$  lei), SaFIR – (securities settlement system) will suffer modifications, the tariff will be updated accordingly, without any other formality

Commissions and fees listed herein along with the general principles, as a part of the Bank General Business Conditions and the Account Operating Rules, may be supplemented with the Bank's decisions.

According to the law concerning payment services, the foreign currency transfers, in any currency, within the European Economic Area (EEA) must always have a cost option of 'shared' (SHA). This means that (for example for an USD transfer from Romania to Austria) each party will pay the costs incurred at their own bank, as is already the practice in the case of EEA currencies payments. Please note that when you submit a foreign currency transfer order in Alpha Bank online banking to a country within the EEA, the only available commission type will be "SHA" – Alpha Bank charges will be payable by sender, other banks' charges being born to the beneficiary (deducted from the paid amount). SWIFT fees are not charged in the case of SEPA payments in euro.
